7) Legislative Report: Peter updated based on AFDA conference attendance. Dignity Health in Phoenix is having major issues with interfacility transport providers who have a CON (Certificate of Need) to provide interfacility transport in Phoenix metro area. They have introduced two bills HB-2197 which would repeal all CONs and HB-2124 which would change the interfacility CON structure. No direct impact for PVFD. HB-2124 could impact many fire districts which rely on interfacility transport to fund EMS. HB-2197 would have a major impact on ambulance services if the CON process was disbanded and likely result in the same issues that caused the CON process to be implemented.

Julee Recker is working on a Masters degree in grant writing through NAU and will be working in the department to apply for grants. The grants through AZ DFFM (Department of Forestry and Fire Management) require PVFD to be a cooperator with DFFM which requires responding individuals to have their "red card." Currently we have no one with a "red card."
